

Macal Truck Tarp

PRODUCT DESCRIPTION

Macal Truck Tarp are cast vinyl film coated with specific adhesive designed to give a permanent adhesion on highly plasticized PVC banners or tarpaulins. Macal Truck Tarpaulin is designed for computer cutting, fast weeding and can be printable in digital print machines.

The serie is available in six popular opaque matt colours. A matt laminating film is available to protect the printed media, a dedicated Technical datasheet is issued - see 'Macal Truck Tarp Laminated'.

Face Material: 80 μ m, cast vinyl, cadmium free Adhesive: Acrylic clear permanent on plasticized PVC only

Liner: Clay coated 140 g/sqm with grey backprinting.

TYPICAL USE

Macal Truck Tarp are designed for exterior marking applications on curtain-side vehicles. The film shows permanent adhesion on all major Tarpaulin available (Sioen, Dickson, Heytex, Verseidag).

To ensure application suitability, always test the proposed construction under actual application and end-use conditions before going into full production.

COLOR MATCHING

Customer colour matching service is provided by MACtac. This colour match can be requested from a minimum quantity of 10 rolls (500 lm).

PROCESSING

Especially designed for flatbed and roll to roll signcutting machines. The white colored film is also printable in solvent, Eco-solvent, Latex and UV inkjet printing on wide-format printing equipment. Printing results are expected to be satisfactory from a larger viewing distance.

APPLICATION METHOD

Macal Truck Tarpaulin can be applied either in wet or dry application methods. Detailed instructions are given in the TB 6.1 "Guidelines on handling, converting and applying Macal Truck Tarp Film."

SHELF LIFE

2 years when stored at 15 to 25° C and $\pm 50 \%$ relative humidity (in the original packaging).
